



## THE MERGER PROCESS - WHY?

# IN 2024 THE HAMILTON WORKINGMEN'S CLUB AND THE HAMILTON COMBINED RETURNED SERVICES CLUB MERGED. WE LOOK AT WHAT LFD TO THE DECISION.

Bringing the Hamilton Combined Returned Services Club and the Hamilton Workingmen's Club together in a merge process was a relatively smooth one but the path to get there was certainly a winding one,

Tom Hogan was there for every twist and turn over a threeyear period.

Not surprisingly, there was resistance to giving up what had been built up since the end of World War 2.

But as Hogan explained, the club had become chattel rich and cash poor. Membership over the previous 10 years had fallen from 1800 to 500 and only about 100 were making regular use of the facilities.

In that time the available finances had taken a hit.

The accounts were being dipped into in trying to maintain services and the ever-increasing repairs to an aging building were a crippling problem. This, together the natural attrition of an aging membership, affected bar turnover negatively.

With each month showing increasing losses, it was obvious that the club could not continue as a going concern.

Hogan was part of a lobby which influenced some key decision making. After the calling of a special general meeting there were substantial personnel changes on the Management Committee and he rejoined it.

The situation had become precarious – the club could no longer afford bands for evening functions, the kitchen costs had become uneconomic as use dwindled and while subsections like darts and eight ball enjoyed good support, it was not enough.

One suggestion presented to the members at another special meeting involved combining with a snooker-8ball venue but was rejected outright once the fine print had been carefully examined and being found to be unacceptable to the Club members.

The new committee then focussed on the "merger" road and an extraordinary emergency general meeting was held on May 26, 2024.

Members of the HCRSC, who were also members of the Workingmen's club, talked it up, Hogan recalled. They talked about the comfort, the meals available and the general décor that the HWMC provided.

But the deal was probably sealed by inviting the President of Clubs New Zealand to speak at this meeting.

The motion was then presented for discussion and eventually approved by 84 of the 100 eligible voters present. This authorised the current members of the management committee of the Hamilton Combined Returned Services Club to take all necessary steps to effect the merger.

One of the many advantages of this merger allowed the HWMC to apply to increase their gaming machines to a maximum of 24.

Hogan first visited the HCRSC as a 21-year-old in uniform having been called up for National Service under the ballot system and serving with the artillery in the Territorial Force.

The Hogan family came to Hamilton in the 1960s. Tom's father was an Inspector of Schools and Tom himself went into the education field spending 40 years teaching within the wider Hamilton district.

Tom Hogan served as President of the Combined Returned Services Club from 1995 to 2000 and was awarded life membership in 1995.

He said that he was, "absolutely delighted" with the merger outcome allowing active additions to the Workingmen's Club subsections.

"It was by far the best move we could have made - we should have done it before we did,"

Every piece of club memorabilia was photographed and the information stored electronically.

There was a lot of work for both merge committees especially in proofreading the terms of engagement to ensure that the rights of the members of both organisations were protected.

The doors of the Hamilton Combined Returned Services Club finally closed on June 16, 2024.

### A CLUB HISTORY

The journey to the Hamilton Workingmen's Club in 2024 marked what is almost certain to be the final move for the Combined Returned Services Club.

The last home in Rostrevor Street was opened in October 1957 by Major-General Lindsay Merritt Inglis, a military officer who had become a magistrate in Hamilton four years earlier.

Entry to an evening social gathering that night was priced at 10 shillings for a double and five bob for a single.

Committee chairman P Yendell, under the heading 'At last this club —' wrote "after years of work, after many anxious times, after much heart-burning and financial hangovers, we now have a club building worthy to be ranked among the best of its kind in New Zealand".

The 65-year plus tenure in the building proved the project was a success.

Yendell noted all those years ago there were still problems ahead "but problems are there to be solved".

"When that has been done, club life will develop the richest fruit and we'll find again the selfless fellowship we've fought for since 1939-45.

"Until all plans have been completed, your committee ask you to bear with present difficulties."

In late 1945 The Waikato RSA and the Hamilton Branch of the 2nd NZEF Association joined social forces

to operate the combined club, working with an overdraft of Stg2000.

The original home serving tea, sandwiches and ales was the "Black Hut" in Garden Place, opened in 1945.

It was built during the second world war to provide bed and breakfast for soldiers on leave or in need – and it also provided the public with lunches.

But the numbers didn't add up and 18 months later Stg1900 of the overdraft had been spent "and the Bank was definitely unfriendly in attitude".

A new committee was installed and turned the finances around – so when the Black Hut was sold the club had four Garden Place sections and was in credit.

In those days members operated under a locker system – bottles of beer were pre-paid and left in a locker to be collected by the buyer. A similar system operated at the Raglan Club.

It's a far cry from today when drinks are served over the counter and paid for using a plastic card.

The Black Hut was eventually sold at auction in 1949 for Stg2600 to St Joseph's Parish in Fairfield.

It's noted that the Hut was "reputedly of poor timber". In fact it was heart rimu. It was a residence for the parish priest, then, a year later, became a school and parish hall for a further 36 years before being demolished.

The club operated for several years as a land proprietor - but with no home of its own. What was described as some "horse trading" resulted in exchanges which left the club financially sound and with a two storey building in north Victoria Street where it reopened for business.

It served until May 1957 and in October, with more "horse trading" done, the club opened in Rostrevor Street debt free and money in the bank.

Combined Returned Service Club members were aided by the business community to build the new home.

It featured a committee room and kitchen, a ladies' lounge for returned service-women, a reading room, a "magnificent" games room featuring three (soon to be four) billiards tables, indoor bowling mats and, "another outlet for the energetics clubmen" - dart boards.

The booklet published to celebrate the opening – from which information for this story is taken - noted a smoke room would be a popular rendezvous with its Formica-topped tables and handy chairs when the club "finally received its liquor charter".

As progress continued, ladies were permitted into the gentlemen's lounge (but not to the bar) – then into the games room to watch snooker being played.

Now the doors had been opened, a women's committee was formed, and successful lobbying began to enable women to have full access to the club—and wives and widows were admitted as members at a reduced fee.

The longevity of the club was assisted when sons and sons in law - and daughters and daughters in law were welcomed as members.

The building continued to serve members through to June 2024, when it closed for a final time.

The decision to merge with the Hamilton Workingmen's Club had been announced two months earlier.

## MEET THE MANAGER NATHAN HARTLEY

Nathan Hartley's first 100 days as the manager of the Hamilton Workingmen's Club are being spent very much in a getting to know you phase.

And he loves what he's seeing.

"The people are happy – I've got ideas, but this is a time to listen to staff and members, look at opportunities to improve, talk to customers and subsections and look where we can help them grow," he said.

Nathan follows in the footsteps of long serving manager Ken Marcum.

The father of two has come to the Hamilton Workingmen's Club from his role as head of food and beverage for the Sky City Entertainment Group where he spent more than 10 years.

He has been working in hospitality in New Zealand for 15 years – initially in Christchurch as an executive chef for Continental Event Catering, then, having move north, as executive sous chef at The Langham in Auckland and executive chef at the Stamford Plaza.

The latest move brings him back to a community environment where he is particularly comfortable.

Nathan is from England's southwest - he was born in Bristol and spent a lot of time on the south coast in Southampton.

By the time Nathan left school in 1990 he had already developed an interest in cooking, and his first job was in a 30-bedroom hotel in the New Forest between Southampton and Bournemouth. Two premier league football clubs yes (though it will be one next season) – but one thing Nathan did not develop was a passion for soccer.

He was assigned to the sweet section as a patisserie chef and thoroughly enjoyed it. The job in the New Forest launched a career which would take him around the word.

Doing the opposite of the traditional Kiwi Overseas Experience to the UK, he headed for Sydney to work there during the 2000 Olympics. Having been introduced to the Sydney hospo scene he made a brief trip to New Zealand before returning to London.

He then ran the catering department at the Natural History Museum in central London – then headed to the Caribbean to run a bar and restaurant in Antigua, a popular British Commonwealth tourism destination.

Then it was back to London and a three year spell at the Spearmint Rhino – "at the time it was a top gentlemen's club and would be visited by well-known celebrities."

He then spent five years as the owner of The Little Cook based in Colchester and around that time met wife to be Sarah.

Nathan continued to be the nomad though, and having sampled life down under, opted for a move for the family to New Zealand – attracted by the beaches and barbecues.

"I always wanted to live in another country," he said.

Their first child, James, was two – "we said if we're going to do it, do it now."

First stop was Christchurch – a three year stint which began five months before the major earthquake which claimed more than 180 lives.

Part of his responsibility post-quake was providing thousands of meals to people in the city.

Businesses became another quake victim and Nathan headed north to work in Auckland for three years before being lured to the Waikato.

The role as head of food and beverages brought a different kind of pressure, and there were many highlights.

"My favourite bits were doing things for charity - one being providing a hangi in Garden Place."

The Waikato Times wrote the July 2022 Matariki event was Nathan's brainchild as SkyCity's food and beverage head. Several hundred people queued for kai from the pit dug in a pebbled seating area.

Funds raised from the \$10-a-head meals went to a charity which provided cooked meals for people in need.

"It was just an idea, I didn't know if it was going to be allowed, but the council has been really good. Everything has been donated so everything we make goes to charity," he told the Times.

His latest move to the Workingmen's Club is one he welcomes.

"This is more community based without the corporate pressures – I see so much potential here and it's such a lovely club.

"The people are great and there is so much scope to do things."

One of his main targets will be to attract more members through the doors – and to see more members in the 30-40 year age bracket being involved.

"The club is safe and secure, it has parking available and is economical – and it has so much going for it."

Nathan is based in Cambridge with Sarah and James, who is studying law. Daughter Niamh is studying in Dunedin and plans to be a forensic psychologist.

# THE VISITORS TONY AND MAY MARCHIONI

Tony Marchioni keeps apologising for not being well enough organised.

He's looking through one of five well-thumbed 3B1 notebooks which document a history of devotion and care to club members but can't find certain dates.

He's 92 in September, so it's pretty understandable - but we get there.

"Last visit February 2023," Tony's wife of 36 years, May, points out.

The couple spent 23 years making hospital and rest home visits to members, bearing gifts of flowers and toiletries.

There were, of course, protocols.

"The club would call us, and we would aim to make a visit in the next day or two. We would check with the hospital, if people were staying three or four days, we would make a visit," Tony said.

It might be one or two a week, but it was a nonstop labour of love for all those years.

"It was very seldom that people would refuse.

For a lot of the time Tony would make the visit while May looked around the hospital for a carpark - they were in action long before the multi-storey carpark made visits to the hospital a lot easier. In the earlier days Sunday visits were preferable because parking was easier.

"I enjoyed it - it was worth doing. They were pleased to see you and we were pleased to see them. They got something out of it, and we got a lot of pleasure - it wasn't hard work," Tony said.

Tony traces his family line back to northern Italy.

His grandfather immigrated to Australia in the late 1800s dreaming of becoming a millionaire, as did hundreds of his countrymen who went searching for gold. The gold rushes caused a huge influx of people and Australia's population swelled 430,000 in 1851 to 1.7 million in 1871

He then tried his luck in the South Island.

"He didn't become a millionaire," Tony confirms.

But the Marchioni family stayed in New Zealand. Tony's dad worked on the railways, and Tony was born in Taihape, then headed down State Highway 1 to live in Utiku on the main trunk line.

As the Second World War came to an end, the young Tony was being groomed for a career in the Post Office, but two years in an office was two years too long.

He convinced his dad that he should follow him into railways, albeit at the potential expense of free time for the keen rugby player and athlete to play sport.

And so, it was full steam - and it was steam - ahead into a new career which kept Tony employed for 40 years and saw him finish as a staff instructor before retiring in 1995.

It also involved a transfer to Hamilton – and nine years in Kawerau, before a return to Hamilton where romance would bloom, again.

Tony and May - who grew up on a farm near Raglan - attended a singles dance at Waikato University.

Tony spotted May and approached her daughter asking if she would mind if he danced with her "sister".

Several decades on, Tony has yet to convince May that it was a genuine mistake.

They married in 1989 – both for a second time - and have lived in their home in Dinsdale for almost 30 years.

The staircase and the size of the home is presenting new challenges as the years advance – in recent time Tony was frustrated to find he had a heart condition which restricted the amount of oxygen being pumped into his blood.

Doctors told him they didn't want to operate, but the guy who clocked up a few marathons in his time gets by.

The twice weekly visits to the club are getting fewer, and asked what keep them busy today Tony quips "just trying to get around".

Tony and May both reflect with a lot of pride on being part of a team effort that kept the visits going.

Also on the team was Peter Karl and wife Elisabeth. Peter kept the tradition going once Tony and May stopped making calls.

"When we stopped, I was slowing up with health issues but Peter did a wonderful job."

"We made hundreds of visits, and I enjoyed every one of them – it was a boost for the patient, and it made us feel good."

### SNOOKER & BILLIARDS SUBSECTION

### REMEMBERING MICHELLE



### FISHING SUBSECTION

The Hamilton Workingmen's Fishing Club section is a friendly group of fishing enthusiasts, welcoming members of all experience levels - from beginners to seasoned anglers.

With a membership of 70 men and women, the club offers a great opportunity to enjoy fishing in a sporting and social environment. This year we were excited to welcome new members from the Combined Returned Services Club fishing section.

The club subsidises fishing charters to popular fishing spots throughout the Waikato and Coromandel regions. Some of our favourite destinations include Raglan and Kawhia on the West Coast as well as the mussel farms off Waikawau in the Coromandel. Additionally, this year saw two charters heading out off Maketu in the Bay of Plenty.

Snapper is the main catch on our trips but members reel in a variety of other fish including gurnard, terakihi, kahawai, kingfish and trevally.

Our charter operators are experienced skippers who know their coastline and ensure trips only proceed in safe weather conditions. Club charters typically run from September through to April with occasional winter trips depending on interest and conditions.

The more experienced anglers often venture to the West Coast venues, while the mussel farms are perfect for newer members or those who prefer calmer waters. Whether you're a seasoned fisher or just starting out, there's a place for everyone at our club.

The club's annual tournament is held each March and to be eligible, members must have completed seven raffle nights throughout the financial year. The revenue from raffle sales plays a vital role in the funding of the tournament and allows the club to subsidise 50 per cent of the cost of charters across the year.

Traditionally, the tournament has been hosted in Coromandel Town, but in 2024 it was moved to Tapu to reduce costs and provide a fresh experience. The event features prizes for the heaviest catches across five categories - snapper, kingfish, trevally, kahawai and gurnard with prizes totalling \$2700. The weekend also includes a dinner, prizegiving ceremony and a post tournament breakfast, with accommodation and meal costs subsidised by the club.

The club holds a "heaviest snapper" competition across the year with cash prizes for first, second and third.



### LEARNING ABOUT ROBERTO

AFTER INDOOR BOWLING SUBSECTION
MEMBER ROBERTO SARAVIA DIED,
FELLOW MEMBERS LEARNED A GREAT
DEAL MORE ABOUT HIM — THANKS TO
RICHARD SWAINSON'S OBITUARY IN THE
WAIKATO TIMES, WHICH THE TIMES HAS
KINDLY ALLOWED US TO REPUBLISH.

When Roberto Saravia took charge of the Mill Street Field his cooking made headlines in both his adopted home of Hamilton and his native Argentina.

The year was 2013, the event a prelude to a rugby test match between the All Blacks and Argentina's First XV. Serving upwards of 150, overseeing the mass barbecuing of 400kg of steak, six lambs and 10kg of sausages, Roberto was in his element. He told the Waikato Times, "it is to bring people together and welcome the Pumas". Locals and visiting

fans alike enjoyed his mastery of the giant, public asado where meat is slow-cooked for hours over a bed of hot wood-ash, New Zealand manuka being just right for the task. They also warmed to the presence of the cook himself, whose wide smiles and broad laughter were infectious.

Roberto was vibrant and charismatic. He toiled in a variety of jobs and occupations across three countries before finding his niche, enjoying success later in life, "monetising his cultural heritage" as his wife Ann Hardy puts it, drawing on cooking skills taught him in youth by a beloved grandmother. His barbecue stall became something close to a Hamilton institution, serving barbecued meat with pungent chimichurri sauce to crowds at the Home Show, the Ngāruawāhia Regatta and lastly at Gourmet in the Gardens. When he gained New Zealand citizenship, then Hamilton East MP David Bennett described him as simply "the man who feeds us".

The public recognition was of a type sought by most immigrants, those often challenged by the perceived need to prove themselves over and over again in a new country. Roberto, says Ann, "got the inclusion that he wanted" and was proud to become a New Zealand resident in 2009 and later, a citizen.

Ramon Roberto Saravia was born July 2, 1950, in Buenos Aires, Argentina, one of the two children of Ramon Alejandro Saravia and Adela Maria Saravia (née Butkus). As a child he was particularly close to his maternal grandmother Anna Maria, who hailed originally from Lithuania. Cooking lessons extended beyond Argentine cuisine, incorporating the dumplings of her native land.

Roberto's early education was often balanced uncomfortably against a need to contribute to the family income. He was first employed at the age of seven, running errands in a panel beater's garage, working mornings before going to school in the afternoon. At nine years old he had a job in his uncle's battery shop, soldering batteries. The lead and sulphuric acid fumes irritated his lungs. If the business was a profitable one, Roberto himself was paid but a pittance. Working from such a young age inevitably impacted on Roberto's education. Tired in class, he often fell asleep.

In 1962, aged 12, he was sent to the Escuela Naval Militar, the military academy of the Argentine Navy. Here he discovered he was no sailor or

soldier, lasting six months only. It was an outcome he never regretted, given the potential fate of classmates destined to fight in General Galtieri's ill-judged Falklands War two decades hence. Roberto was heard to remark later, "thank God I didn't continue on and die in the General Belgrano".

Shortly afterwards the Saravias shifted north to Cordoba where Roberto's father took a job in a university library whilst nursing an ambition to himself write a book. At the age of 14 Roberto secured his dream position, working as a sports journalist for a Cordoba radio station. His speciality became car racing. A long time car enthusiast, he described the experience as being "in the box": if not literally within a commentary box, calling races, figuratively doing exactly what he wanted.

Sadly, the job was a voluntary one, contributing nothing to the family coffers. Subsequent employment was by necessity better remunerated, but it was not always dull. Roberto was for a time a singer and dancer in musical theatre. He became a skilled practitioner and teacher of the tango. He learnt magic tricks and, an early entrant to the gig economy, would perform at children's parties.

In his mid-20s Roberto worked as caregiver to a terminally ill man, a poet by the name of Attaliva. Around the same time, he met Beatriz Sintes, who was to become his first wife, and the pair moved to Uruguay where they named their first born child Favio Attaliva in honour of his former employer. Roberto worked for a time in a photo laboratory. They were to later have a second son, Leonardo Sebastian.

In Uruguay, Roberto became a driver and owner of taxis. Always hard working, he proved as dedicated a provider for his own family as he had been for that of his parents and sister. Favio and Sebastian wanted for nothing and enjoyed a close relationship with their father. Sebastian describes Roberto as "a kind man, a funny man", highly skilled in a variety of fields, who was "always caring about people", who gave his children a strong moral compass.

With the end of his marriage, Roberto emigrated to New Zealand in a period when many of his fellow Argentines and Uruguayans were also leaving the lands of their birth, searching for new opportunities in the wake of the region's early 2000s financial crisis. He had also personally survived a major heart attack.

Working as a welder, building caravans for a Hamilton based company, Roberto became an integral part of the city's emerging Latino community. A natural people person, a lover of food, music and dance, he formed firm friendships with fellow Spanish speakers who were also a long way from home.

It was through this community that Roberto met Ann Hardy, a university lecturer, at a Latina jewellery selling party. He was the only male at the event - there was a degree of contrivance involved. Ann had been approached by a student and that student's mother with a suggestion that she might like to make his acquaintance. Roberto had also been advised to attend. It was 21st century matchmaking in action

The initial meeting went well enough to encourage a second. However, Roberto's departure soon after, for an extended visit to Uruguay, seemingly put an end to the burgeoning romance. When he did return it was with fresh resolve. Travelling from the airport to Ann's office, he spoke directly, saying "you work with words, and I work with my

hands: we could be a good team".

The sentiment proved compelling. With both parties prepared to take a chance, things progressed quickly. Roberto and Ann were married in 2008 at the University of Waikato's Lady Goodfellow Chapel. The reception, at a colleague's house was both joyous and well catered, with Roberto himself supervising the cooking. Sebastian, who had travelled from Uruguay to attend, thereafter himself settled in the Waikato, together with his partner Rochelle.

Roberto's passion for fishing announced itself the day after the wedding, a surprise to Ann. Being from distinct cultures, languages and backgrounds, there were further revelations ahead. Roberto taught Ann and many others to tango and performed at the Hispanic Spring festival for several years. He impressed as a skilled archer, magician, gardener and later a competitive bowler at the Cosmopolitan and Hamilton Workingmen's Clubs. He encouraged Ann to learn Spanish as she gently improved his English.

Around 2010 Roberto snapped a tendon in his arm whilst at work. Although this responded well to treatment his employers took the opportunity to make him redundant. Unemployed at the age of 60, he was never again to find formal, paid work.

Stressful in the short term, the challenge brought out the best in Roberto. No stranger to career upheaval, he and Ann purchased a caravan and began to sell candy floss at festivals and A & P shows on the weekends. It was a forerunner to greater success. When the market became wary of sugar, barbecued meat in the Argentine manner became Roberto's vocation.

The night that the barbecue operation was launched it attracted the attention of Dallas Fisher, head of Montana Catering. On the strength of a tasting, Fisher offered Roberto and Ann a stall at the Rhythm and Vines Festival in Gisborne, a large and prestigious event. The honour proved impractical to take up given the infancy of their business, but it was indicative of their product's worth and future.

Given barbecuing over hot ashes required outdoor conditions, sunny days could result in large profits. Rainy days required an equivalent tolerance of losses but on balance the business generated sufficient funds for Roberto to travel back to Argentina and Uruguay more than once.

Time spent in Uruguay saw Roberto establish a warm connection with his two grandchildren. He also particularly valued the experience of rising early and eating breakfast with son Favio. In Buenos Aires he and Ann visited Roberto's sister Liliana, with whom he had always kept in touch.

A trip to Uppsala, Sweden, accompanying Ann to an academic conference saw Roberto able to additionally visit his late grandmother's country of origin, where he was taken by one elderly woman's similarity to Anna Maria, so much so that he addressed her enthusiastically in Spanish.

Alas, the astounded Lithuanian geriatric lacked the words to reply.

It's been another busy and eventful year and we have played on courses both near and far.



## PROFILE CHE ORTON

# WE CATCH UP WITH CHE ORTON — A FAMILIAR FACE ON THE HAMILTON WORKINGMEN'S CLUB STAGE TO FIND OUT WHAT HE DOES BETWEEN PERFORMING SHOWS FOR MEMBERS.

In the wake of Covid opportunity didn't knock for Che Orton – it called.

The entertainer, a regular performer at our club, had been upstaged by the epidemic – and with the lockdowns there was no work for someone who had been a full time performer.

He had taken on work as a first responder for St John, and it was on one trip with patient on board that his phone rang. And rang. And rang.

Che couldn't take the call, but as soon as he had finished his job, he checked his messages to find an urgent "call me now".

A colleague in the music industry had to pass up work on a cruise ship leaving Japan in a few days time – and suggested Che should do it.

Almost three years later the weeks away performing a couple of sets as a guest entertainer on board the Diamond Princess as it journeys around South East Asia and on the Tasman Sea have become a regular gig.

And when we spoke in March, Che was preparing to fly to Los Angeles and then on to a port in Mexico for his next trip.

It's not quite the life of former police detective Jack Grayling in the BBC's latest light-hearted crime programme The Good Ship Murder. Che must be prepared to perfection with music sheets to supply to a seven piece band who have an hour to get to know him.

Then over the next week he will perform a couple of shows – one as Elvis Presley – more of that later - and one as himself.

And truth be told, the work certainly pays the bills – but travelling solo on a cruise ship and thinking about the wife and family at home isn't Che's idea of a dream getaway.

But it is a good place to be for someone who was "politely" asked to leave Fraser High School as a teenager.

It wasn't so much that he was a troublesome student – the personable young man actually thought of some of his teachers as friends – he just wanted to play music rather than study the three Rs.

Che was born in Thames and grew up in Paeroa where he stayed until turning six when his dad joined the team at Terry Booth Toyota in Hamilton. He went to Nawton Primary and Maeroa Intermediate before Fraser High School.

It was a rule in the family that if you left school you had to have a job.

Che had been the "lackey" at Lloyd Davis Panelbeaters and when he told his boss he was now out of school, he was told to turn up at seven the next day.

Short work stints followed – Che was a "hammer hand" building Skyline garages, he loved building trusses at PlaceMakers then did some painting before becoming an orderly at Waikato Hospital.

It was a job that he stayed in for seven years – and led to him meeting a nurse named Lucy. They celebrated thier 20th wedding anniversary the day before our chat.

And through it all has been music.

When he was 15 and a member of The Drifters Rock and Roll Club, plans were announced to hire an Elvis tribute artist for an annual event.

Che cheekily volunteered to do the job – and to his surprise was accepted. Weekends performing with the likes of Tom Sharplin and Ritchie Pickett at Te Rapa's Red Gables followed.

He met Paul Madsen who had a Bee Gees tribute band, and Che – who loves Elvis and the Bee Gees – joined it, performing as Robin Gibb.

As an 18-year-old he and Madsen then went on a national tour, covering Elvis, Neil Diamond and Roy Orbison numbers. Their Bee Gees tribute band, Orton, Madsen and Paul Jeffries, also performed at the M Resort in Las Vegas.

That was almost 20 years ago. He had just become a dad and decided to leave the hospital and try his hand as a solo entertainer full time, performing in clubs such as the Workingmen's.

His calendar soon filled up – but when he was invited to perform at a Drifters Rock and Roll Club event, he said he would perform with a band as audiences had seen a lot of him solo.

"The problem was, I didn't have a band."

Over the next five months Che created Che Orton Band and after several attempts he settled on the perfect combination for the performance.

Meanwhile, Orton was Elvis. In 2007, Elvis Presley Enterprises announced they were looking for the "best representation of Elvis Presley's music and legacy".

Twenty-four entertainers travelled to Memphis during Elvis Week that year to compete, and the event has become an annual one.

Che has qualified to sing there three times and last year was named one of the top five performers.

"My goal was to make the top 10 – but just performing at Graceland was a bonus."

From Graceland to cruise ships to being a dad in Hamilton is a varied set to say the least.

He and Lucy have three teenage children – Eva, Ben and Mila – and when he's home, Che has the school drop off job.

#### ALL SHOOK UP

When Che was preparing to perform as Elvis one night on a cruise, he started to succumb to an unwanted symptom of rock and roll – sea sickness.

"I was seriously thinking I would not be able to perform," he recalled.

A suggestion of a quick trip to the ship pharmacy for tablets had a hook. Preparing to be Elvis involves over an hour of applying the wig and sideburns. And the sight of Elvis Presley asking for pills may well have been headline news – or at least resulted in some suspicious minds.

A crew member dashed out and returned with the required seasick tablets which, thankfully for Elvis fans, had the desired effect.

And it's clear it's his favourite place – and he doesn't forget that it was performing at clubs around the country that helped him get to where he is today.

"I love performing at the Workingmen's Club – it's home – and people come down from Auckland and Tauranga to hear me."

He's also got a slightly different view of schools.

Che has returned to Maeroa Intermediate to speak – and recently presented Nawton primary with a guitar. Maybe a return to Fraser isn't out of the question...



### A DOUBLE IN HUNGARY

Two months shy of his 18th birthday Hamilton's Deacon Nichols found himself on a world stage of a sport enjoying a renaissance.

The Hamilton youngster qualified for the boys' world darts masters in October – and it required him to fly for the first time.

The Hamilton Workingmen's Club member played three games in Budapest, Hungary, against German, Polish and Dutch teenagers.

The competition proved tough – he was eliminated in pool play – where the race was to win four games – but did manage to win two against the Pole.

He had the perfect chaperone too – his mum and manager Daphne, who also played in a section of the wider tournament and bowed out early.

"We got to see Professional Darts Corporation players including Beau Greaves, who is mum's favourite woman player, and Neil Duff," Deacon said.

English player Greaves, 21, is among the top women darts players in the world while Northern Irishman Duff - who was almost 50 when he turned professional – is a former world champion.

For Deacon the trip of a lifetime was more about taking aim at the dart board than checking out historic sites.

Budapest, one of the largest cities in Europe, dates back in various forms to before the birth of Christ and today is a major centre for banking and finance.

Deacon did get to the retail part of the city – and spotted familiar McDonalds and Burger King signs.

The teenager comes from darts playing stock – and his mum and aunt Corrine Walters-Lui are both prominent players in the Workingmen's Club, having been encouraged in the sport by their father.

So with a lot of darts history in the family, perhaps it's no surprise that Deacon lists a darts icon from the 1980s as his favourite of all time.

That's the Crafty Cockney Eric Bristow, whose televised battles with the likes of John Lowe, Bobby George and Jocky Wilson became prime time viewing.

Bristow – who was just 60 when he died - was ranked number one in the world five times during an era when the sport went hand in hand with pints of beer.

The sport lost its allure in the 1990s, but it was a player Bristow mentored – Phil Taylor – who played a key role in setting up a rival darts body to the British Darts Organisation and getting it back on screen and filling halls around the world – including Claudelands Globox Arena.

Deacon recalls being about 11 when he and an uncle took on mum and his aunt in a darts game at home.

"Then mum brought me down to the Workingmen's Club to throw darts – I wasn't very good, but in time I felt a lot more comfortable."

Tournaments followed, and battles against similarly aged players to the point that as a 16-year-old he was playing in junior championships – and qualified for the world event.

Lesson from Budapest?

I've learned about the pressure and the exhilaration – you have got to be in the zone – but also have fun. Relax, and you'll score well".

Being at the club has also enabled Deacon to play pairs with Englishman Michael Smith, who visited the club during the New Zealand Darts Masters in 2024, a year after being ranked world number one. Smith was beaten in the tournament at Claudelands in the quarter finals by Luke Humphries, who went to beat Australia's Damon Heta in the final.

Deacon is practicing his darts every day – and also enjoying providing a voice over for characters in games and series, mainly on YouTube.

#### NOTICE OF MOTION/REMITS FOR THE ANNUAL GENERAL MEETING

It is proposed by the Executive Committee that the following alterations be made to the Constitution of the Hamilton Workingmen's Club, the original wording is bracketed in black with the proposed change bracketed in red, a full copy of the current constitution is available on our website <a href="www.hwmc.co.nz">www.hwmc.co.nz</a> or on request from reception:

#### CONSTITUTION

Under the Incorporated Societies Act (2008) (2022)

(Note: To cover mixed membership a gender includes each other gender) – Removed

- 3.1. (c) (To provide facilities and support for persons who have served in the New Zealand armed forces, or any allied country, or part of the British Commonwealth or the United Nations.)
- 4.1 (a) (Males and Females) (Individuals) who have attained the age authorised by the Sale and Supply of Alcohol Act 2012 and any amendments made subsequent.
- 4.1 (b) (Males and Females) (Individuals) under the age authorised by the Sale and Supply of Alcohol Act 2012 and any amendments made subsequent.

- The membership application form shall include the forenames, surname, date of birth, residential address and occupation of the candidate and an undertaking that they (consent to membership and agree to) abide by the Constitution and House Rules (See Rule 35) and the (Bylaws page 16), of the Club.
- (5.6 The Club will maintain an up-to-date register of members in accordance with the Incorporated Societies Act 2022.
  - 5.6.1 The Register of Members will at all times be administered in accordance with the Privacy Act 2020 and the Clubs Privacy Policy.
  - 5.6.2 The register will contain:
    - (a) the name of each member; and
    - (b) the last known contact details of each member; and
    - (c) the date on which each person became a member; and
    - (d) all other information prescribed by the regulations (if any).
- 5.6.2 The Club will update its register of members as soon as practicable after becoming aware of changes to the information recorded on the register.)
- 10.2 (i) The election shall be by secret ballot on the Club's premises. Voting will be between the hours of 11am and 7pm for three (3) days (commencing on the Saturday) (to be determined by the Executive Committee and to commence no later than seven days) following the AGM.
- (I) Any member elected or appointed after the date of the annual election shall hold office for (one year) only until the next annual election.
- (12.4 The President shall be the contact person with whom the Registrar can contact when needed.)
- 17.5. The normal rules of debate shall be followed, each member speaking once only to motion or amendment except the mover who may reply. The mover of any resolution or substantial amendment shall be allowed five (5) minutes in which to introduce his proposition and ten (10) minutes for reply, or vice versa, any other speaker will be allowed five (5) minutes.

  The Chairman shall decide whether any amendment proposed is a substantial amendment or not. If free discussions of any subject is desired, any member may move that the meeting go into committee on that subject and such motion shall be immediately put and decided by a show of hands. In committee no member shall speak for more than five (5) minutes at a time. When in committee any member may move that the ordinary meeting shall be resumed, and such motion shall be immediately put and decided by a show of hands. ("In Committee" means that no minutes or record of debate is kept, and that the debate is confidential to those attending the meeting concerned and "Into Committee" has a corresponding meaning'.)
- (17.7 Minutes are required to be kept for all meetings.)
- (18.3 Minutes are required to be kept for all meetings.)
- 22.1(g). The Club shall make returns required by (Section 23 of the Incorporated Societies Act, 1908 or by such other statutory provision for the time being in force and shall comply with all the requirements of such Statute and other Regulations thereunder) (the relevant New Zealand legislation and comply with all the relevant requirements of those Acts).

- 24.1. The Executive Committee shall have the power to suspend or expel from the (f). membership any member of the club for misconduct (either within or outside the Clubs premises) for any wilful infringement of the Clubs rules or any by-laws, house rules made by the Executive Committee but before any member is suspended or expelled (he or she) (the member) shall be notified by the Secretary of the date, time and place of the meeting of the committee at which his (or her) suspension or expulsion is to be considered. Such notice shall be deemed to be given if posted by registered post to the member's usual or last known address not less than five (5) clear days before the date of the committee meeting, or if no address be known, by posting in the Club's Notice Board for five (5) days before such meeting and it shall not be necessary to show that the member actually received such notice. The member shall be entitled to appear before such meeting of the Executive Committee and be informed of any complaint or charge against (him (or her)) (them. (He or she) (The member) may put forward any explanation of defence (he or she) (they) wish to make and the Executive Committee may then decide either to suspend or expel or reinstate the member. If the member fails to attend the meeting the Executive Committee upon proof of notices to (him (or her)) (the member) as above provided may proceed in (his (or her)) (the member's) absence. No member may be suspended under this rule unless a majority of the members of the Executive Committee meeting vote in favour of suspension, expulsion or reinstatement. Any member of the Executive Committee may call a ballot on the question of suspension or expulsion or reinstatement of a member. The above applies to all suspensions not covered by automatic suspensions as shown in the House Rules and offences in the By-laws. That the Executive Committee shall make sure that any member on charge is made fully aware that (he or she) (they) may call witnesses in (his) (their) defence, both verbally in the presence of another person, and in writing, at the time of the hearing.
- 26.5. Visitors under 18 years of age may be admitted to the designated areas of the Club as defined by Executive Committee from time to time, provided they are accompanied by a legal Guardian, in accordance with the (Sale of Liquor act) (Sale and Supply of Alcohol Act 2012 and any amendments made subsequent).

#### 29. (DISPUTES) (COMPLAINTS, DISPUTES AND APPEALS)

- 29.2 All members of the Hamilton Workingmen's Club Incorporated will be covered by these rules and may be subject to penalties, sanctions or orders imposed by the Disciplinary Committee.
- 29.3 If the conduct of any member should be reported as objectionable, a member, guest, visitor, staff member or any member of the public making the complaint shall do so in writing to the Manager, as soon as practical and no later than one calendar month after the incident.
- 30.2. Such Regulations or By-Laws shall not be inconsistent or repugnant to the provisions of the Incorporated Societies Act, (1908) (2022) and its amendments or of these Rules.
- 32.3 Resolution in lieu of meeting: A written resolution may be passed via this method in accordance with Sections 83 to 86 of the Incorporated Societies Act 2022.
- 33.1. The Club may be voluntarily dissolved as provided by (Section 24) (section 5(3) and subpart 5 of Part 5) of the Incorporated Societies Act, (1908) (2022) and its amendments. Any funds or property remaining after settlement of just debts shall (be disposed) (transferred to another not-for-profit association) of in accordance with the decision of the members meeting deciding upon a dissolution. Provided that no member of the Club at the dissolution shall personally be entitled to participate or benefit in any way in the distribution of such funds. Rule 33 "Dissolution of the Club" shall not be altered without approval of the Inland Revenue.

35.3. No liquor shall be removed from the Clubs premises (except liquor purchased through the Off Sales counter. Liquor purchased from the Off sales counter must be removed immediately from the Club's premises).

#### **BY LAWS**

- Under rule 30 the committee may make By-Laws (not inconsistent with the Incorporated Societies Act (1908) (2022) and not inconsistent with the (Sale of Liquor Act 1989) (Sale and Supply of Alcohol Act 2012) for the regulation and management of the Club or any part of its business.
- 2. The following By-Laws have been adopted but do not form part of the Rules and may be added to, changed or deleted without reference to the Registrar of Incorporated Societies (in accordance with Rule 24.1.(c).)

Members are reminded if they have any questions pertaining to the Annual Report it would be appreciated if these could be put in writing and be in the hands of the Club Secretary five days before the Annual General Meeting on Sunday 29 June 2025. These will be posted on the main notice board when available.

## **HWMC PRESIDENT'S**REPORT 2025

It's been a year of exciting progress and meaningful change at the Hamilton Workingmen's Club. I'm proud to share some of the highlights and acknowledge the incredible support from our members, staff, and Executive Committee throughout this journey.

One of the most significant milestones was our successful merger with the Hamilton Combined Returned Services Club Inc, approved by members at the extraordinary meeting in August 2024. We also welcomed the Hamilton Returned Services Association to our Commerce Street home. These changes have brought new energy to the club, including a welcome boost in membership and a vibrant revival of the 8 Ball subsection.

In April, we were pleased to appoint Nathan Hartley as our new general manager. Nathan brings fresh ideas and a strong commitment to the club's future, and we're excited about the direction we're heading under his leadership.

Looking ahead, we're also preparing for the new Incorporated Societies Act 2022. To meet the new requirements, we have drafted an updated constitution which will be presented at the upcoming annual meeting. While the changes are mostly compliance-related, they lay the groundwork for stronger governance and a more resilient future.

Membership continues to grow steadily, reaching 6906 in March—nearly back to our pre-Covid peak. This is a testament to the value our club offers and the strong sense of community we've built together.

Sadly, we also said goodbye to many valued members over the past year. Our heartfelt condolences go out to their families and friends. Their presence and contributions will not be forgotten.

As we approach the 2025-26 Executive Committee elections, I encourage every member to get involved. Your voice matters. Voting will take place on Saturday July 5, Monday July 7, and Tuesday July 8, and nominations close at 11pm on Saturday June 21. In times of change, your participation is more important than ever.

Finally, I warmly invite you to attend the 2025 annual general meeting on Sunday June 29 at 3pm in the Conservatory. It's a great opportunity to connect, reflect, and look ahead together.

Thank you for your continued support and commitment to the Club. The future is bright - and it's even better with you in it.

H Wood-Rowe reminded everyone that they needed to be a financial member of the Hamilton Workingmen's Club to be in attendance.

#### TRIBUTE TO DECEASED MEMBERS:

A moment of silence was observed as a tribute to members who had passed away during the year. H Wood-Rowe noted that we have been notified of 85 deaths last year and there will be others we are not aware of. Our condolences to all those affected by a members passing.

#### PRESIDENT'S REPORT AND FINANCIAL STATEMENTS:

H Wood-Rowe started her address to the members by stating that she hoped they had all received their yearbook publication, as it is now available both online and in print format, and had read her report.

H Wood-Rowe stated that she was pleased to be able to attend the AGM today in view of the newly completed Pavilion green cover and that it looks fantastic. This work has all been completed during difficult times for both the Club and the country as a whole. She stated that the staff

do an exceptional job maintaining the premises under these circumstances whilst still holding functions during these times of reduced staffing. She asked the members to show their appreciation by way of applause. She stated that the Executive Committee, which had had some new members added at the last election, has been working well together. Work has been progressing on the Constitution with expectation of bringing a new Constitution forward to be reviewed before the next AGM. The strategic plan which is due for review is also being worked on with the hope of operationalizing some of those activities.

She outlined some items that will be discussed in general business. These included the approach from the Combined Returned Services Association proposing that they merge with us. Also the Hamilton RSA have asked to merge with us, all this will be discussed in general business. H Wood-Rowe invited R Donaldson to give the financial report.

R Donaldson spoke about the \$140k cash loss for the year before depreciation. He highlighted the contributing factors of the lack of tenant/rent for the property at 18 King Street but that we have now secured a long term tenant after implementing an incremental contract.

This will obviously continue to impact our bottom line but not to the same extent as we see here. Unfortunately the work on the pavilion, which is now completed, ran over budget but was also out of action for longer than we hoped for, meaning that we missed out on all the income we would normally have made in the months from April 23 to January 24. Income since completion has been good and looks like it will be successful and that will improve our income over this year. He stated that the majority of inwards correspondence seen at the Executive Meetings involves price rises from suppliers. We are trying to manage these alongside keeping prices as low as we can for as long as we can. It is starting to be unrealistic to only increase prices once a year but this will need to be looked at by the incoming Executive Committee. He stated that the loss is not ideal but it should start looking better in the next financial year.

R Donaldson asked if there were any questions about the 2023/24 financial accounts. There were none.

H Wood-Rowe asked for a brief synopsis on the item. A Sandel stated that basically she is opposed to the fact that the Club President is used as the Secretary because she says that is a bit of a conflict of interest as it puts her in a very vulnerable position.

H Wood-Rowe replied to T Kuiumdjian that these were not Constitutional issues. He replied they are not constitutional issues they are ones to do with following the rules. She replied that she did not feel that the AGM was the place to bring them up that this was more a Committees business. He replied that he disagrees respectfully, he believes the AGM is the perfect, ideal and proper venue to discuss matters relating to Subsections and the way they are, what their responsibilities are, he then said to the general membership he didn't know if anyone there disagreed with him. A couple of members called out that they did. He continued that he thinks it is an appropriate topic for the AGM.

**B Simpson** (0007) spoke in reply and stated that he has a bit of experience in this area, as most people know, having retired recently as the Club President after 27 years. He replied to T Kuiumdjian by saying that although what he wishes to discuss might mean a lot to you this is not the forum for it and that there are already guidelines for the running, operation and finances of Subsections and they are firmly in place. This has meant that for the positions of Committee we have some extra numbers and this means we will go forward to an election which is good as it maintains the competitive and democratic process. This means we will need returning officers.

H Wood-Rowe stated that the Executive Committee have appointed G Meyrick (Primary), R Laird, T Marchioni and T Ryan as returning officers for the upcoming elections. G Meyrick will hold the authority to second others if required.

#### **CONFIRMATION OF APPEAL BOARD:**

H Wood-Rowe discussed the current members of the Appeal Board and the passing of Mike O'Toole.

#### **CONFIRMATION OF PATRON:**

H Wood-Rowe confirmed that C Sullivan was previously appointed as the Patron of the Club for the rest of his natural life and asked if he would like to speak.

C Sullivan congratulated H Wood-Rowe on her new position and wished everyone well in the upcoming election. He hopes all will take the time to participate. His feeling is that the Club is in very good hands and although we have had some ups and downs it is nothing compared to some other places. He wished members all the best.

#### **GENERAL BUSINESS:**

A Sandel (1402) stated she would be reading from papers as she gets tongue tied at times. She stated an occasion arose recently when she needed to contact the HWMC Executive Committee Secretary. Nowhere on the Executive Committee website could she find that person. She has since been advised by the Executive that the Club Secretary is also the Executive Committee Secretary, an arrangement that she personally finds most concerning. She is sure that the Club Secretary can do the job quite adequately. What she is most concerned about is that she is being put into a situation where she may find her loyalties being split between a person who employs and pays her wages and ensuring that the Executive is informed of ALL matters including those that management may not want the Executive to know. She then stated may she suggest that the Executive reconsider this situation by reinstating the role of Executive Committee Secretary to an ELECTED officer on the Committee appointed by voting members.

**H Wood-Rowe** replied to A Sandel that she will have read the Constitution, (A Sandel replied yes), and the Committee appoint a Secretary which we have. The Secretary is the Committee's Secretary, (A Sandel replied correct,) and there is no need for a separate Secretary.

A Sandel replied that she understands that but she still thinks that the Secretary being the Club Secretary is in a very compromised situation should any untoward situation ever occur. That's all, she is just protecting the Secretary.

**B Simpson** (0007) replied the issue around the Secretary for the Club is covered by the Constitution . The Constitution says that the Executive Committee is empowered to appoint staff including the Manager and the Secretary and that role could both be held by one person. Just for your information, as I am not sure how long you have been a member, the Club has been in existence since 1955 and those have been the boundaries within the Secretary has been placed and we have never, to date, had any conflict of interest or issue around the appointment of a staff member as the Club secretary, who also deals with the minutes of the Club Executive Committee, and unless you wanted to put forward a remit with the appropriate notice at a future AGM to change the Constitution all is in order.

**A Sandel** stated she wanted to leave it for your thoughts over the next year because yes there will be a remit going in next year, when we get notified in plenty of time to lodge the remit because we didn't get any notification this year.

**H Wood-Rowe** replied there was sufficient notice given when it was posted up on the boards.

T Kuiumdjian (3546) stated that the 60+ subsection has been repeatedly told by the Club Management, and apparently endorsed by Helen who co-signed a letter saying, that the 60+ Subsection Committee was not formed at their AGM. He stated this is totally and utterly untrue. We have the signed minutes of the meeting which clearly shows the members on that Committee having been nominated, seconded and elected into those roles. This ties in with my second problem, the control of the subsections funds. The Club Manager, in his opinion, appears to be hell bent on getting his hands onto the subsections funds, which is about 20 odd thousand dollars. The Club manager does not want to have any dialogue with the Committee in regards to the expenditure of the funds. Traditionally the 60+ committee as he understands it, has helped fund or virtually soley funded the midwinter Christmas lunches midyear and end of year for which we ran at a loss of over \$6k last year. Given the nature of the loss he was very concerned with how the funds were being expended.

H Wood-Rowe replied that she wished to stop him there as they have had a discussion about this. T Kuiumdjian replied that was correct but that he has not had a resolution and this is a good forum for discussion. H Wood-Rowe replied that you don't get a resolution immediately, that we said we would look into your accusations, and they were accusations, and investigate it. We explained that we had AGM coming up along with being busy with other things so it might take a little bit of time. This is not the place to bring this up, this is not a Constitutional issue. T Kuiumdjian replied I disagree with you Helen, respectfully, if you

cannot discuss the formation of sub committees at your AGM and the misuse of the powers that be, this is the perfect place for it. **H Wood-Rowe** replied that she was going to stop him there as he was making very strong accusations and that he couldn't make accusations like that when they have not yet investigated. **T Kuiumdjian** replied that he has factual documentary documented evidence. The evidence of all of the Committee members who were at the AGM and elected, the minutes of the AGM, all saying that the Committee was formed – and here I have the Club Manager and yourself saying something else.

H Wood-Rowe replied that he was preempting something when we haven't finished investigating it. **T Kuiumdjian** replied he wanted to bring it up here because he wants to make sure it does get investigated and not buried. **H Wood-Rowe** replied that he could leave it at that.

**Brett Clayton** (5704) asked to speak – he stated he had there an election of officers that were elected with John Brown elected Chairman and himself as Vice Chairman and that there is 5 committee members and he hopes he is not out of order. **H Wood-Rowe** thanked him and said she was sure that would all be taken into consideration during their investigation.

**H Wood-Rowe** asked if there was anyone else that wished to comment – there was not. She then said to **T Kuiumdjian** that they will carry on with reviewing his complaint and the matters that he brought up last week and will get back to him but this is not the place for discussion.

**T Kuiumdjian** replied that once again he respectfully disagrees with that.

H Wood-Rowe (4101) spoke with regard to the Hamilton Combined Returned Services Club (HCRSC). We have been approached by the HCRSC who have voted at their AGM, subject to us accepting them, to merge with the Hamilton Workingmen's Club. We are currently in the process of doing the required due diligence around this but what we would like to present to this meeting is that with the hope that the merge will be accepted at a Special General Meeting that in the interim those members that have been displaced because that Club has closed its doors, be able to come and utilize our Club in the Short term. We will have a Special General meeting once due diligence is completed and we can discuss the findings. We do believe this is an opportunity for all, the Club will be bringing with it assets and we can provide a place for them to come too. They have a very strong 8 ball section and there are lots of pros. At the moment we are not voting to merge – what we are asking you to do is allow us to accept those members in the interim. A call for any comments was made – none made.

**MOTION:** That the HCRSC members be allowed to use our full facilities with their current membership of the HCRSC Card and we continue to do due diligence around this potential merger and bring it to a Special General

Meeting

**Moved:** J Brown (4229)

Seconded: A Sandel (1402) CARRIED

2 AGAINST

**P Stocks** (1459) – asked if we had any idea how long it would be until the Special Meeting.

**H Wood-Rowe** replied no not an exact date, that it would be no sooner than 3 weeks but that notice would be given. It will be as quickly as can be expedited.

H Wood-Rowe (4101) spoke with regard to the Hamilton Returned Services Association (HRSA). They have had a room in the HCRSA building and have also expressed a preference to come over to be with the Hamilton Workingmen's Club – the HRSA AGM is on the 22nd and they will vote at that AGM – there is no real due diligence to do because they are not bringing any liabilities or assets with them but it will be a place for them to set up an office. In anticipation of that AGM being held we will have a lot of benefit of them coming over to us as they have the contemporary vets who are all still members of the HRSA, they will bring with them their membership and their families which will also boost our numbers.

**MOTION:** That subject to the Hamilton RSA AGM approving a merge with HWMC, we carry on with the due diligence necessary around a potential merger and bring it to a Special General Meeting.

**T Kuiumdjian** (3546) asked if they will join up as full members of the Hamilton Workingmen's Club. **H Wood-Rowe** replied that is correct.

H Wood-Rowe asked T Ray (ClubsNZ invited guest) if he would like to speak. T Ray stated he felt it was a good move for both parties, just one concern he has is that if HCRSA members come to Club under their card they are not members of Clubs NZ and will not be able to take part in CNZ sports tournaments and they do have very strong 8 Ball and Darts sections. His suggestion would be that those people that wish to compete join us so that they can play under our Club – temporary membership does not apply with regard to the tournaments so just something for those people to be aware of.

#### HONORARIUMS:

H Wood-Rowe reminded the members that Honorarium is paid annually in arrears at the discretion of this meeting.

**MOTION:** That Honorarium remains the same as the previous year with the exception of the President honorarium being split evenly (\$7500.00 each) between B Simpson and H Wood-Rowe.

**T Kuiumdjian** (3546) asked for clarification on the amounts that were to be paid.

**H Wood-Rowe** replied Certainly - President: \$15000.00, Treasurer: \$6000.00, Vice President: \$2000.00, and Executive Committee members \$50.00 per meeting to a maximum of \$600.00 each. All amounts stated are nett of w/tax and ACC. She stated it has been those amount for about the last 20 years.

T Kuiumdjian (3546) commented it was time for a pay rise.

**H Wood-Rowe** (4101) spoke about a member whose has been a member for nearly 50 years and in that time he has made a valuable contribution to the Club and has done a lot of work, often at short notice when they have been needed. They have given us very reasonable rates on the small occasions that they have charged us. It was decided with this in mind that the Executive Committee would like to give Lindsay Russell (0917) Life membership at the Hamilton Workingmen's Club

**MOTION:** That Lindsay Russell (0917) be awarded Life Membership at the Hamilton Workingmen's Club.

L Russell graciously accepted his life member badge and thanked the members.

#### **Notes to the Financial Statements**

#### Hamilton Workingmen's Club (Inc) For the year ended 31 March 2025

#### 1. Statement of Accounting Policies

#### **Reporting Entity**

Hamilton Workingmen's Club (Inc) (the 'Club') is a club incorporated under the Incorporated Societies Act 1908. The Club provides recreational facilities as a fellowship and social club for the use and welfare of its members.

#### **Basis of Preparation**

The financial statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice ("NZ GAAP"). They comply with Public Benefit Entity Standards Reduced Disclosure Regime ("PBE Standards RDR") and Public Benefit Entity International Public Sector Accounting Standards ("PBE IPSAS") that have been authorised for use by the External Reporting Board for Not-for-Profit entities.

Hamilton Workingmen's Club (Inc) is a not for profit public benefit entity and is eligible to apply Tier 2 PBE standards on the basis that it does not have public accountability and is not defined as large.

#### **Basis of Measurement**

The financial statements have been prepared on the historical cost basis.

#### **Functional & Presentation Currency**

These financial statements are presented in NZD.

#### **Specific Accounting Policies**

The following specific accounting policies which materially affect the measurement of the Divisional & Combined Statement of Financial Performance and Statement of Financial Position have been applied:

#### Revenue

Revenue is recognised as follows:

#### **Donations and grants**

Donation and grant income is recognised depending on whether or not there is a "use or return" condition attached. Where no use or return conditions are attached, the revenue is recorded as income when the cash is received. Where income includes a use or return condition, it is initially recorded as a liability on receipt, and subsequently recognised within the Statement of Financial Performance as the conditions are met.

#### Revenue from providing goods and services

Revenue is recognised on an accrual basis as underlying goods and services are provided.

#### Interest Income

Interest is recognised on an accrual basis.

#### Stock on Hand

Inventories are recognised at lower of cost and net realisable value, determined on a first-in first-out basis. There is no damaged or obsolete stock.

#### Trade Receivables

Trade Receivables are recognised at estimated realisable value.

#### Income Tax

No liability from income tax arises on the basis that the Club is a non-profit entity that trades within the circle of its membership.

#### Goods and Services Taxation

Revenues and expenses have been recognised in the financial statements exclusive of GST. All items in the Statement of Financial Position are stated net of GST except for receivables and payables which are stated inclusive of GST.

#### Investment Property

Investment properties are valued initially at cost then depreciated over their useful lives using the same rates as land and buildings.

#### Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on a basis consistent with those from previous financial statements.

#### Property, Plant & Equipment

Property, Plant & Equipment are recognised at Cost less aggregate depreciation. Depreciation has been calculated using the rates to spread the assets cost over its estimated useful life. Gains and losses on disposal of fixed assets are taken into account in determining the operating result for the year.

#### 2. Non-Recurring Items

On 4 September, 2024 the Hamilton Combined Returned Services Club Inc (HCRSCI) merged with the Club. As a result, the assets including the property at Rostrevor Street were transferred to HWMC with a fair value of \$4,144,000. The Rostrevor Street property is currently listed for sale.

As part of the merger HWMC agreed to pay the liabilities of HCRSCI at merger date and subsequent expenses relating to the merger. The net transaction value as at 31 March, 2025 is \$3,894,060.

For the year ended 31 March, 2023 a gift of \$45,000 was received from the Hamilton Senior Citizens Association Inc on the windup of their organisation. In the 2024 HWMC paid for the preparation of the final windup accounts.


